

# California Air Resources Board Information

## ATTENTION CALIFORNIA COMMERCIAL TRUCK OWNERS!

The California Air Resources Board (CARB) is the “clean air agency” that protects public health, welfare, and ecological resources through the reduction of air pollutants. CARB is the enforcement body when it comes to diesel-powered medium-duty trucks in California, and one of their primary duties is to define vehicle emissions standards. The state of California has established regulations to meet these standards.

These regulations no longer allow some diesel-powered vehicles to be operated on California roadways. If you own a business and operate older model diesel vehicles, you may need to replace your truck due to these regulations. If your truck is out of compliance, CARB can place a DMV registration hold on your vehicle.

## **Class 4-6 California Air Regulation Board Compliance**

As of January 1, 2021, any diesel truck with a manufacture year of 2006 or older, will no longer be in compliance with the CARB Diesel Truck Regulations. All Class 4-6 diesel powered vehicles must be equipped with a 2010 or newer engine model year (EMY). View the table here to determine when your vehicle needs to be replaced.

## **Class 7-8 CARB Compliance**

All Class 7-8 diesel powered trucks with a manufacture date of 2004 or older must be completely replaced or have a 2010 or newer EMY or they will not meet compliance with new regulations.
